## Northwest Chinese School Offers Reduced/Waived Tuition for Chinese Language Classes for Students from Low Income Families

Reinforcing her commitment to Chinese Language & Culture (CLC) learning opportunities for all school-aged students (K-12), Northwest Chinese School (NWCS) proudly announces her 2022 – 2023 School Year Financial Aid Program (FAP) for low-income families (Metro-Seattle Standards). Beginning with the 2022 Fall semester, all NWCS students, current or new, from families with Adjusted Gross Income (AGI) lower than Washington State standards (details are listed on the Application Form: NWCS FA Form-1088), can expect to pay reduced tuition (up to 50%) or to enjoy 100% tuition waiver (tuition free) for one 2-hour Chinese Class only. In other words, this policy is not applicable to any selective classes at NWCS.

No mission for NWCS is more important than to encourage her students to learn or continue to learn the CLC in the pursue of their brighter future. Therefore, NWCS shall continue to help all eligible students with FAP, especially those from families being heavily impacted by the Covid-19, pay the reduced/waived tuition upon approval by NWCS FAP Committee for a 2-hour Chinese Class.
