## NWCS ONLINE TECHNOLOGY CONSENT FORM

Dear NWCS Parents of children under the age of 13,

In order for NWCS to continue to provide your student with the most effective tools to enhance their learning, school Admin and teachers may use educational web-based services and applications. Many of the Terms of Service and/or Privacy Policies of these applications state that, due to Federal Law, any users under the age of 13 must obtain parental permission to use their sites and often require an email address or other personal identifiers information.

Our recently embarked web-based learning is operated not by NWCS, but by third parties, ZOOM, some of the applications used are Web-based Mandarin learning, YouTube, Google Search Engine, etc.

For our students to use these programs and services, certain personal identifying information -generally the student's name and registered IDs -- must be provided to the web site operator, in this case, Admin and teachers and ZOOM. Under federal law entitled the *Children's Online Privacy Protection Act (COPPA)*, these websites and NWCS must provide parental notification and obtain parental consent before collecting personal information (photo/audio/video recordings) from children under the age of 13. The law permits schools like NWCS to consent to the collection (photo/audio/video recording) of personal information on behalf of all its students, thereby eliminating the need for individual parental consent given directly to the web site operator (ZOOM).
